### Booth Rules & Exhibitor Standards:

- All Artisan booth space is a 12'x12' area which will be located on Market Street in Downtown Clearfield.
- Tables, chairs, tents/canopies will not be provided. Please remember to bring your own.
- Trailers are prohibited.
- Set-up is from 8:30 AM-10:30 AM. Tear down will begin at 5:00 PM.
- Artist can't sublet the space to other parties, and **sharing or splitting single booth spaces is no longer allowed.**
- Artists are responsible for removing all garbage created at their booth.
- **Artists will be contacted with confirmations & space numbers following the application deadline**, and the CRC reserves the right to limit or restrict spaces.
- All work must be of original design, handcrafted, and produced under the direct supervision of the creator/artist.
- The work exhibited and the booth must match the quality and style of work as represented in the submitted digital images.
- All Jewelry must be hand made by the creator/artist.
- For two dimensional art, a minimum of 50% of the hanging artwork must be originals. Prints must be so marked and bins kept to a minimum.
- Commercially manufactured goods will not be displayed or offered for sale. Artists violating these conditions may be asked to close down their booth, or remove any article deemed objectionable at the discretion of management.
- Proper insurance and protection of the work is the responsibility of the exhibitor.
- Demonstration of your art during the festival is encouraged, and will earn you a discount on your booth fee.

### Jury Information & Requirements:

- ONLY WINNERS FROM PREVIOUS YEAR ARE EXEMPT FROM THE JURY PROCESS.
- Applications are considered by a panel of 3 artist and 3 professional business persons.
- You will be notified if accepted/declined within 5 days of application.
- **You are required to include 7 clear images (JPEG's with resolution between 72 and 150 ppi), most representative of the art you plan to exhibit along with this application.** 5 of the photos should be of your latest work, 1 of you creating your art, and 1 of your booth (if available). If accepted to the festival these photos will be used to promote your work for the festival.
- Please include an artist statement (200 words or less about your inspiration, your process etc.). This statement is not required, but will help in the jury process and with the promotion of your work if accepted.
- **Jury Fee:** This year's application will require a non-refundable **jury fee of \$15.** If you are accepted, this fee will be applied to your booth cost. If you are not accepted, this fee will not be refunded. **This fee must be included with this application.** The balance of your total booth space cost (calculated below) will be collected at the time of acceptance.
